Subject: Updated Declaration of Conformity with POPs, PFAS, and TSCA Regulations

We hereby declare that the products supplied by AEB Torneria Automatica S.r.l. comply with the applicable requirements of the following regulations:

1. Regulation (EU) 2019/1021 on Persistent Organic Pollutants (POPs)

Our products do not contain substances listed in:

- Annex I (prohibited substances),
- Annex II (restricted substances),
- and do not generate unintentional emissions listed in Annex III, nor exceed thresholds for waste management under Annex IV.

This includes compliance with the latest amendments, including Regulations (EU) 2025/718 and 2025/1399, which set updated limits for PFOS and related compounds.

2. PFAS (Per- and Polyfluoroalkyl Substances)

Our products comply with the restrictions on PFAS, including:

- Perfluorooctane sulfonic acid (PFOS) and its derivatives,
- Perfluorooctanoic acid (PFOA) and related substances,
- Perfluorocarboxylic acids (PFCAs) with chain lengths C9–C14.

We ensure that these substances are either not present or are below the Unintentional Trace Contaminant (UTC) limits as defined by current EU regulations.

3. TSCA Section 6(h) – U.S. EPA

Our products do not contain any of the five Persistent, Bioaccumulative, and Toxic (PBT) chemicals restricted under TSCA Section 6(h), including:

- Decabromodiphenyl ether (DecaBDE),
- Phenol, isopropylated phosphate (3:1) (PIP (3:1)),
- 2,4,6-Tris(tert-butyl)phenol (2,4,6-TTBP),
- Hexachlorobutadiene (HCBd),
- Pentachlorothiophenol (PCTP).
